Regular Meeting

April 28, 2015

The regular meeting of the Board of Fire Commissioners was called to order at 7:33pm by Mr. Caruso. The notice was read, and the flag salute was lead by Chief Zuccarelli. Roll call was taken, present were John Toutounchi, Shayamal Joshi, Joseph Colón, Thomas Caruso. Robert Buscaglia was absent. Also in attendance were Mr. Joseph Youssouf and Rachel Davis.

Motion made by Mr. Joshi to accept the minutes from last meeting.

Second: Mr. Toutounchi 4-0 all in favor (1 absent)

Motion made by Mr. Joshi to increase the amount of 22 cameras to \$13,462 (quote attached).

Second: Mr. Colón 4-0 all in favor (1 absent)

- Furniture, carpet and paint in Chief's office—need all furniture off floor by May 19th.
- Chief Zuccarelli requested to send seven members to Baltimore convention. Board approved.

New Business:

Motion made by Mr. Joshi to hire a QuickBooks consultant, not to exceed \$2,100.

Second: Mr. Toutounchi 4-0 in favor (1 absent)

- Mr. Caruso mentioned SCBA policy, adding requirement of advanced SCBA. Mr. Youssouf will do a resolution for next month.
- Mr. Youssouf discussed Board's capability of appointing officers
- Mr. Youssouf discussed contract proposal received from Pearce Manufacturing, specifically the chasse prepayment option.

Motion made by Mr. Joshi to accept Resolution Authorizing Exercise of the Chasse Prepayment Option Provided for in the Pearce Contract, Chasse Prepayment being in the amount of \$327,435, upon receipt of signed voucher and invoice.

Second: Mr. Colón 4-0 in favor (1 absent)

• Mr. Youssouf discussed April 1st letter from firefighter requesting to retain helmet after he retires.

Resolved that once Board receives a hold harmless letter from said firefighter, the Board declares the helmet in question as excess property, as it is no longer needed, and authorize its conveyance to said firefighter for no consideration. Vote: 3 in favor, 1 abstain

<u>Audience</u>:

- Ross: Advanced SCBA policy question.
- Jack: Any handicapped parking spots? Once construction is done, Township will be redoing parking lot lines. Need to talk to Township about sidewalk.
- Frank: Will we have access to driveway when construction starts? Park on side lot until done.

Gerard Stankiewicz, CPA from the firm of Samuel Klein and Company, arrived to meeting and discussed Report of Audit (attached).

Motion made by Mr. Joshi to move to Executive Session at 8:50pm.

Second: Mr. Colón 4-0 in favor (1 absent) Regular meeting of the Board of Fire Commissioners resumed at 10:14pm.

Motion made by Mr. Buscaglia to adopt a Social Media Policy based on the NLRB Social Media Policy from 2012 (attached).

Second: Mr. Joshi Roll call: Mr. Toutounchi, Mr. Colón, Mr. Joshi, Mr. Buscaglia, Mr. Caruso 5-0 all in favor

Motion made by Mr. Joshi to adopt the Resolution Establishing a Part Paid Fire Department (attached).

Second: Mr. Caruso Roll call: Mr. Toutounchi, Mr. Colón, Mr. Joshi, Mr. Buscaglia, Mr. Caruso 5-0 all in favor

Mr. Youssouf explained that this is a two-step process—first step was adopting it tonight by title and must be published in its entirety in the newspaper; then schedule it for a second reading. After published, we conduct a public hearing on the Resolution. At the conclusion of the hearing, the Board then adopts it a second time, and it's in place.

Mr. Joshi thanked Andy for taking care of the flags outside.

Motion made by Mr. Joshi to reimburse Fontana for personal property damage to clothing in the amount of \$200 for his suit pants and convey to him that this will be the final time.

Motion made by Mr. Joshi to adjourn meeting at 10:22pm.
