**Ralph:** Five foot TV's in small rooms?

A: We got a great deal on them. Also, TV's are hooked up to computer systems and eventually will be set up as a command post, so when large situations similar to Sandy and Irene occur, it will be beneficial to the Chief to make decisions from that room with different data sources on the TV's.

**Joe Fontana:** Shouldn't it be moved into the Chief's room?

A: It gives the Chief more room to work, it's a matter of space, and the Chief has access.
