WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

The Building Improvements were approved in 2021 for \$500,000 of which \$210,000 was paid down in 2023 and 2024. The remainder of \$290,000 was financed through the Monmouth County Improvement Authority, with final payment in 2027.
