Regular Meeting

<u>Chief's Report</u>: Chief Haas reported that some of the rigs needed minor maintenance, and he is waiting on the pricing for the failed hoses.

Commissioner Story said new cones are needed for every rig; he will go through the old cones and try to salvage some. Board agreed.

Captain Celano discussed RedNMX with the Board. He expressed his dissatisfaction with the app, and his opinion was to stay with IAmResponding. Commissioner Fogarty suggested sitting down with RedNMX to let them know what the issues are.
